## **AGREEMENT FOR DISSEMINATION OF THE REPLICATE EU PROJECT (‘Agreement’)**

### **Introductory Provisions Article 1**

- (1) By this Agreement, the Parties regulate their mutual rights and obligations in connection with the Dissemination of the EU Project REPLICATE (hereinafter REPLICATE) at the MCE Conference 2019 in Venice on June 13 and 14, 2019 (hereinafter: MCE 2019).
- (2) The person responsible for the performance of this Agreement on the part of MCE is Giorgio Prister, President of MCE.

The person responsible for the performance of this Agreement on the part of the CDF is: Alessandra Barbieri– Manager of European project Office and Project Manager of H2020 Replicate project

### **Subject Matter and Term of the Agreement Article 2**

- (1) The subject matter of this Agreement is the MCE support for the dissemination of REPLICATE at MCE 2019
- (2) The Parties hereby conclude this Agreement, in terms of the support from MCE to the dissemination activities by the CDF at MCE 2019.

### **Rights and Obligations of the Parties Article 3**

- (1) MCE hereby undertakes to enable the following elements for REPLICATE
  - One 5 minutes speed dating slot for a speaker in a session of the event
  - 1 table and chairs at the exhibition area - – stand to be provided by sponsor

- Small size EU project logo under the heading "EU projects" in printed media and the conference website with a link to the EU project website (logos of this section arranged in alphabetical order)
- Point of presence for material distribution
- 2 free registrations
- Additional registrations may be purchased at a price of 300 € VAT per participant

(2) The CDF undertakes to pay for the above defined elements provided by MCE **the amount of € 2.000,00 + VAT** (in words: € two thousand + VAT).
